The EuroQol Research Foundation (hereinafter: EuroQol) hereby certifies that the above translation followed the established EuroQol translation methodologyⁱ for this type of translationⁱⁱ. This methodology, based on the International Society for Pharmacoeconomics and Outcomes Research (ISPOR) guidelines, was developed with the aim of achieving semantic equivalence to the original and ensuring the new version would be easily understandable and culturally acceptable to respondents drawn from the target population.

Suitably qualified professionals who were bilingual speakers of Hindi and English were recruited locally in India by our translation partner and contracted by EuroQol to translate the EQ-5D-5L to Hindi for India using the UK English ‘source’ version and relevant Hindi reference files, if available. This version was then tested on Hindi-speaking respondents with a range of socio-demographic characteristics, including patients and healthy individuals.

The translation team members performed all translation work to the best of their abilities as translators and researchers experienced in the field of health-related quality of life research. All translation steps were taken in collaboration with members of the EuroQol’s Version Management Committee, who reviewed reports provided by translators after each stage of the process.

Based on the official report of the translation process submitted by our translation partner and verified by the Version Management Committee, I certify that this translation is, to the best of my knowledge, a valid and accurate translation of the corresponding source English document.
